## Part I - Terms and Conditions of Use

Welcome to [www.unitednoodles.com](http://www.unitednoodles.com) and any related United Noodles online pages, subdomains, mobile pages, QR-code-linked pages, social commerce pages, online ordering tools, or digital services that link to these Terms (collectively, the "Site"). The Site is owned or operated by United Noodles, Inc. ("United Noodles," "we," "us," or "our").

These Terms and Conditions of Use ("Terms of Use"), together with our Privacy Policy and any applicable Terms of Sale, govern your access to and use of the Site. Please read them carefully. By accessing, browsing, using, creating an account, submitting information through, or purchasing products or services through the Site, you agree to these Terms.

### 1. Acceptance of These Terms

If you do not agree to these Terms, do not use the Site. These Terms apply to all visitors, customers, account holders, and other users of the Site. You may use the Site only for lawful purposes and only in accordance with these Terms.

We will not be liable for any failure, delay, error, inability to perform, inability to fulfill orders, service interruption, supply shortage, delivery delay, or other issue caused by events beyond our reasonable control. Such events may include acts of God; flood; fire; earthquake; severe weather; pandemic; epidemic; public health emergency; war; invasion; hostilities; terrorist threats or acts; protests; riots; civil unrest; government orders; changes in law; embargoes; blockades; national or regional emergencies; labor shortages; strikes; slowdowns; supply-chain disruption; transportation delays; product unavailability; equipment failure; internet, telecommunications, payment, or power outages; third-party service provider failures; or other similar events beyond our reasonable control.

## 19. Governing Law and Jurisdiction

These Terms are governed by the laws of the State of Minnesota, without regard to conflict-of-law principles. Subject to the arbitration provision below, you agree that any dispute, claim, or proceeding arising out of or relating to these Terms, the Site, Site Content, products, services, orders, or transactions will be brought exclusively in the state or federal courts located in Hennepin County, Minnesota, and you consent to personal jurisdiction and venue in those courts.

## 20. DISPUTE RESOLUTION; BINDING ARBITRATION; CLASS ACTION WAIVER

**PLEASE READ THIS SECTION CAREFULLY. IT AFFECTS YOUR LEGAL RIGHTS. TO THE FULLEST EXTENT PERMITTED BY LAW, YOU AND UNITED NOODLES AGREE THAT ANY CLAIM, DISPUTE, OR CONTROVERSY ARISING OUT OF OR RELATING TO THESE TERMS, THE SITE, SITE CONTENT, PRODUCTS, SERVICES, ORDERS, OR TRANSACTIONS WILL BE RESOLVED BY BINDING ARBITRATION ON AN INDIVIDUAL BASIS, RATHER THAN IN COURT, EXCEPT THAT EITHER PARTY MAY BRING AN INDIVIDUAL CLAIM IN SMALL CLAIMS COURT IF THE CLAIM QUALIFIES.**

**YOU AND UNITED NOODLES EACH WAIVE THE RIGHT TO A JURY TRIAL AND THE RIGHT TO PARTICIPATE IN A CLASS ACTION, CLASS ARBITRATION, REPRESENTATIVE ACTION, PRIVATE ATTORNEY GENERAL ACTION, OR CONSOLIDATED PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE MORE THAN ONE PERSON'S CLAIMS AND MAY NOT PRESIDE OVER ANY FORM OF CLASS OR REPRESENTATIVE PROCEEDING.**

Nothing in this section prevents either party from seeking temporary or preliminary injunctive relief in a court of competent jurisdiction to protect intellectual property, confidential information, security, or other rights pending arbitration. If any part of this arbitration provision is found unenforceable, the remaining portions will remain in effect to the fullest extent permitted by law.

## 21. General Legal Terms

Assignment. You may not assign any rights or delegate any obligations under these Terms without our prior written consent. Any attempted assignment or delegation in violation of this provision is void. We may assign or delegate these

Terms in connection with a merger, acquisition, sale of assets, restructuring, operation of law, or other business transaction.

**No Waiver.** Our failure to enforce any right or provision of these Terms will not be a waiver of that right or provision. Any waiver must be in writing and signed by an authorized representative of United Noodles.

**Severability.** If any provision of these Terms is held invalid, illegal, void, or unenforceable, that provision will be enforced to the maximum extent permitted or severed, and the remaining provisions will remain in full force and effect.

**Entire Agreement.** These Terms of Use, the Terms of Sale, the Privacy Policy, and any additional terms posted or provided for specific features, promotions, products, or services constitute the entire agreement between you and United Noodles regarding the Site and supersede prior or contemporaneous understandings on those subjects.

**Headings.** Headings are for convenience only and do not affect interpretation.

## Part II - Terms of Sale

These Terms of Sale apply to purchases of products, services, gift cards, prepared foods, specialty items, merchandise, or other offerings made through the Site or through other United Noodles online tools that link to these Terms. They supplement the Terms of Use and our Privacy Policy. If there is a conflict between these Terms of Sale and the Terms of Use for a purchase, these Terms of Sale will control for that purchase.

### 1. Application of Terms of Sale

United Noodles may offer certain products or services online, in store, through phone or email coordination, through QR-code-linked pages, through third-party delivery or ordering platforms, or through other sales channels. Not all products, services, prices, promotions, pickup options, delivery options, or shipping options are available in all channels or at all locations.

Additional terms may apply to specific products, services, promotions, events, catering, delivery services, third-party marketplace orders, or special orders. If additional terms are provided, those terms will apply in addition to these Terms of Sale.

### 2. Eligibility to Purchase

To place an order through the Site, you must be at least 18 years old or the age of majority in your jurisdiction, a legal U.S. resident, and authorized to use the payment method provided. By submitting an order, you represent and warrant that you meet these requirements and that the information you provide is true, accurate, and complete.

### 3. Order Placement, Acceptance, Changes, and Cancellation

When you submit an order, you make an offer to purchase the selected products or services. We may accept, reject, limit, or cancel any order in our discretion, including because of pricing errors, product unavailability, suspected fraud, payment issues, system errors, legal restrictions, age restrictions, operational limitations, or other business reasons.

An order is not accepted until we confirm acceptance or otherwise begin fulfilling it. An order confirmation or automated email confirms receipt of your order but does not guarantee acceptance, product availability, exact price, pickup time, delivery time, or shipment.

If you need to change or cancel an order, contact us promptly at [info@unitednoodles.com](mailto:info@unitednoodles.com) or (612) 721-6677. We will make reasonable efforts to assist, but changes or cancellations may not be possible once an order has been processed, prepared, packed, picked, shipped, handed to a delivery provider, or otherwise fulfilled.

### 4. Payment Terms

Payment terms are within our discretion. Unless we agree otherwise in writing, payment must be authorized or received before we accept or fulfill an order. We may accept credit cards, debit cards, digital wallets, gift cards, or other payment methods as made available by United Noodles or our payment processors from time to time.

You represent and warrant that all payment information you provide is true, correct, complete, and authorized; that you are authorized to use the payment method; that charges incurred by you will be honored by your bank, card issuer, or payment provider; and that you will pay all charges, including applicable taxes, fees, service charges, shipping, delivery, and handling charges.

If a payment is declined, reversed, disputed, charged back, or otherwise not completed, we may cancel the order, suspend fulfillment, seek payment, recover fees and costs, or take other lawful action.

### 5. Pickup, Delivery, Shipping, Title, and Risk of Loss

If store pickup is offered, we will make reasonable efforts to prepare your order for pickup at the selected location and time. Pickup times are estimates and are not guaranteed. You may be required to show order confirmation, identification, payment card, or other information before receiving an order.

If delivery is offered directly by United Noodles or through a third-party provider, delivery times are estimates only. We are not responsible for delays caused by traffic, weather, product availability, address errors, building access issues, unattended delivery locations, third-party delivery providers, or circumstances beyond our reasonable control.

If shipping is offered, shipping dates and arrival dates are estimates and are not guaranteed. We may decline to ship to certain addresses, states, regions, P.O. boxes, freight forwarders, or locations where products cannot lawfully or safely be shipped.

For store pickup, title and risk of loss pass to you when the products are transferred to you or your designee. For delivery or shipping, title and risk of loss pass to you when we transfer the products to the delivery provider, carrier, courier, or other third party, unless applicable law requires otherwise.

## **6. Out-of-Stock Items, Substitutions, and Item Selection**

Because grocery, specialty, imported, refrigerated, frozen, and seasonal products can change quickly, an item shown on the Site may be unavailable at the time of fulfillment. We may cancel unavailable items, adjust quantities, or, if substitutions are permitted, select substitute items in our discretion.

Substitutions may differ in brand, size, flavor, country of origin, ingredients, price, packaging, nutrition, allergen profile, certifications, or other characteristics. If you have allergies, dietary restrictions, brand requirements, religious requirements, or other product-specific concerns, you should not rely on substitutions and should contact us before placing or accepting an order.

## **7. Age-Restricted Products**

Certain products, if offered, may be subject to age, identification, pickup, delivery, shipping, or legal restrictions. These may include alcohol, tobacco-related products, knives, certain medicines, or other regulated items. We reserve the right to refuse, cancel, limit, or require in-person pickup for any age-restricted or regulated product. Valid government-issued identification may be required.

## **8. Returns, Refunds, and Final Sale Items**

Refunds, replacements, store credits, or other remedies are provided in our discretion and may exclude delivery fees, shipping fees, service fees, handling charges, tips, third-party fees, or other non-product charges unless required by law.

No refunds are offered on products or services marked "Final Sale," "No Returns," "Non-Returnable," custom, special order, event-based, prepared, perishable, temperature-sensitive, opened, partially consumed, or otherwise excluded, except as required by law.

## **9. Perishable, Frozen, Refrigerated, and Specialty Products**

Perishable, frozen, refrigerated, prepared, and specialty products require prompt handling and proper storage. You are responsible for timely pickup, receipt, inspection, refrigeration, freezing, cooking, preparation, and storage after the product is transferred to you, your designee, a delivery provider, or a carrier.
